FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Broker Statement

The compromise was over a business debit card which was registered under my name. The business was a grocery store for my parents, I did not work in the store. My father served as a translator for the US military in the Iraq war from 2005 until 2011 and came back with [REDACTED]. Doctors recommended he be kept busy so we decided a grocery store would be great considering my fathers success running 7-Eleven franchises prior to serving our country. The business was put under my name because I agreed I would care for it in the future and made sure I would pass it on to my future offspring. The store did not do so well and ended up closing in 2015. My parents were struggling financially and my father became very ill which we later found out was a type of [redacted] called [redacted]. I stepped up and helped them out as much as I could financially and as soon as I received the letter from United Collections Bureau I gave them a call and explained the situation and circumstances. They offered me the listed settlement with the terms I listed in 8c and the satisfaction date of compromise was on 03/27/2017.
