FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Employing firm when activities occurred which led to the complaint: Bankers Life and Casualty Company

Allegations: In a civil litigation, filed May 6, 2011 with the Court of Common Pleas of Allegheny County, Pennsylvania, [REDACTED] named Bankers Life and Casualty Company (BLC), an insurance company affiliate of the Firm, and two of its agents, Vincent Mariana and Thomas Librich. [REDACTED] alleged the agents persuaded her to liquidate her entire stock portfolio in June of 2009 and invest in an annuity, a whole life insurance policy, and short-term hospitalization insurance with BLC. [REDACTED] stated that when she needed access to the funds in May of 2010 she had to pay substantial surrender charges. [REDACTED] also stated that as a result of the inferior investment vehicles chosen, she suffered additional losses. The parties entered into a confidential settlement and resolved this litigation in August 2014.
