- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

Allegations:	I, Alexis Guerra, am providing this written statement to provide more information on the incident that happened with Bank of America. This incident was a non-securities related incident; I was permitted to voluntarily resign from my firm. I was in violation for opening up a checking account, which was not a securities related transaction for my second cousin. As per Bank of America, a banker/Financial Advisor cannot open up accounts for immediate family members. Opening the account for my second cousin, I was under the impression that I was not opening up an account for my immediate family member and was a distant family member. After opening up the account, however, Bank of America still wanted to view this as



a violation of rules, and would not give me a clear understanding or definition of immediate family vs. non- immediate family member. It was at this time, I was asked to voluntarily resign from Bank of America instead of termination. I hope this gives a clear picture of what happened. I don't have any further proof of correspondence between Bank of America and myself. When I voluntarily resigned, I did it through a company email server, which said, "Good morning, I am notifying you of my two weeks notice, thank you for the opportunity of working at Merrill Lynch/Bank of America."
