• What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.
- How current is this information?
- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- Are there other resources I can use to check the background of investment professionals?

 - An "adjudicated" matter includes a disposition by (1) a court of law in a criminal or civil matter, or (2) an administrative panel in an action brought by a regulator that is contested by the party charged with some alleged wrongdoing.
 - A "settled" matter generally involves an agreement by the parties to resolve the matter. Please note that brokers and brokerage firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

Broker Statement

Capital One credit card was used by my mother when I was in college. I was studying abroad in Costa Rica at the time and was not receiving the statements or bills. I was in Costa Rica from February of 2014 until April 2014. No payments were made on the card at that time. Due to late fees and accruing interest, I owed \$1,124 and could not afford the payments since I was a college student with no income when I returned from my study abroad in Costa Rica. I thought my mother was paying the card as she promised but she was not. I tried to call and make payment arrangements and fell behind. Once I got a part time job and got back on my feet I called to negotiate a settlement. The account was sold to Portfolio (a debt collection agency) and I owed 452.87 as of June 17, 2016. I paid a settlement of \$218.41 in full on June 29, 2016 and am currently at a zero balance. Nothing is owed at this time.
