I, THERESA MANGINES, DENY ALL ALLEGATIONS AUTHORED AGAINST ME BY [CUSTOMER]. I DID NOT SELL THE UBS AG PFD FNDG TRUST IV (UBS PFD) TO [CUSTOMER]. [CUSTOMER] WAS ONE OF THREE HEIRS TO AN ESTATE WHICH WAS LIQUIDATED AND PAID TO THE HEIRS IN CASH, EXCEPT FOR THE UBS PFD POSITION. [CUSTOMER] MADE SPECIFIC AND INSISTENT INSTRUCTIONS THAT THE UBS PFD WAS NOT TO BE SOLD OUT OF THE ESTATE. [CUSTOMER] KEPT HIS 50% OF THE ESTATE AND BOUGHT THE OTHER HEIRS' 50% OF THE ESTATE. [CUSTOMER] THEN OPENED AN ACCOUNT WITH ME AND TRANSFERRED THE UBS PFD POSITION INTO THE ACCOUNT. I STRESSED THE IMPORTANCE OF DIVERSIFICATION TO [CUSTOMER].
