- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and

I was a Private Client Banker in Chase, one day I had a client came into the branch who was trying to deposit checks and making a transfer from her account to her relative's Chase account. I brought the client to the teller window, filled out the deposit ticket and finished the transaction. After the client left the bank, I submit a ticket into the system in order to claim the incentive credit with manager approval. After a few months, Chase's investigation team called me and accused me and said I purposely brought the client to the teller window for the transfer in order to make the bank system show 'cash out' and 'cash in', so I will be qualified to the credit I was terminated with the reason *manipulating the system for incentive.*
