BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

 - A "settled" matter generally involves an agreement by the parties to resolve the matter. Please note that brokers and brokerage firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

Allegations:	On 1/19/2022, Respondent, Dylan Miles Nix, filed an application with the Insurance Commissioner of the State of California (the "Commissioner") for a license to act as a life-only agent with variable contact authority in the State of California. Respondent was convicted on multiple dates for criminal charges (incident dates 6/1/2009, 12/7/2011, 9/27/2012 & 10/25/2016). Pursuant to Section 2183.2(b)(8), Title 10, of the California Code of Regulations, the convictions from 6/1/2009, 12/7/2011, 9/27/2012 & 10/25/2016 demonstrate a pattern of repeated and willful disregard for the law which is substantially related to the qualifications, functions, or duties of an insurance license. The facts alleged show that it would be against the public interest to permit Respondent to transact insurance in the State of California and constitute grounds for the Commissioner to deny the pending



application of Respondent pursuant to the provisions of Section 1668(b) of the California Insurance Code.

Other: The Insurance Commissioner of the State of California entered an order denying the insurance application and issued a restricted license subject of the following terms and conditions: (a) obey all laws and regulations of the State of California, the United States of America, and every state foreign government, and their political subdivisions having jurisdiction over the registrant. (b) The restrictions apply to all renewals, fictitious business names, and new lines of authority, whether or not the restrictions are endorsed on the restricted license. (c) No property right in the restricted license. (d) The Commissioner may, with or without either hearing or cause, suspend or revoke the restricted license. After one year from the date of the execution of the order, the Insurance Commissioner may remove the conditions and restrictions from the license if there has not been a justified complaint against the registrant and neither an investigation nor disciplinary action against the registrant is then pending.
