BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement	Was interviewed by the police after a family member of the girl notified the parents of the girl that I visited their home while parents were on Vacation. I was interviewed for 8 hours completed a stress analyzer test and a swap test. I was asked if I had sex with the girl, I maintain my innocence, I admitted to kissing the girl. I was called back to go in the next day for another four hours after they had spoken to the girl. She told them she had lied about her age to me but that we had consensual sex. When I denied have sex I was let go. About a year later I was charged we 3 counts of sexual conduct with a minor, 2 were for the same date and were dismissed immediately. After the first court date I was offered to plead guilty to a count 3 misdemeanor and I accepted. I had to pay \$200.00 fine complete probation for 2 years and spend 4 weekends in jail for a total of 8 days. I completed everything satisfactory on 08/03/2013.
