- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Regulator Statement

SEC NEWS DIGEST, MARCH 25, 1982, ISSUE 82-57. THE COMMISSION HAS ACCEPTED AN OFFER OF SETTLEMENT FROM BARRY WEISS, IN WHICH HE NEITHER ADMITTED OR DENIED THE COMMISSION'S ALLEGATIONS THAT HE WILFULLY VIOLATED SECTION 10(B) OF THE SEC ACT OF 1934 AND RULE 10B-5 THEREUNDER IN THAT HE INDUCED PUBLIC CUSTOMERS TO IN LISTED OPTIONS BY MISREPRESENTING THE RISKS AND PROFITABILITY OF HIS TRADING STRATEGIES AND THE MEANING OF MARGIN MAINTENANCE CALLS; EXECUTED TRADES IN CUSTOMER ACCOUNTS WITHOUT PRIOR AUTHORIZATION; FAILED TO FOLLOW CUSTOMERS' INSTRUCTIONS REGARDING THE AMOUNT OF RISK THEY WERE WILLING TO ASSUME; AND TRADED AND INDUCED CUSTOMERS TO TRADE IN LISTED OPTIONS NOTWITHSTANDING THAT SUCH TRADES AS EFFECTED WERE INCONSISTENT WITH SUCH CUSTOMERS' FINANCIAL SITUATIONS, INVESTMENT SOPHISTICATION, AND INVESTMENT OBJECTIVES. THE COMMISSION SUSPENDED WEISS FROM ASSOCIATION WITH ANY BROKER OR DEALER FOR A PERIOD OF 15 CALENDAR DAYS, AFTER WHICH, FOR AN ADDITIONAL 45 CALENDAR DAYS, HE MAY ACCEPT ONLY UNSOLICITED ORDERS FROM THE CLIENTS THAT HE HAD ON THE DATE OF THE COMMISSION'S ORDER, AND HE SHALL NOT ACCEPT NEW CLIENTS DURING THE AFORESAID 45 CALENDAR DAYS.
