BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

ON JANUARY 30, 1985, [CUSTOMER], AS TRUSTEE OF THE [CUSTOMER], FILED A CIVIL ACTION AGAINST SHEARSON/AMERICAN EXPRESS, INC. AND DAVID JENNINGS, IN THE UNITED STATES DISTRICT COURT FOR THE NORTHERN DISTRICT OF TEXAS, DALLAS DIVISION; CIVIL ACTION NO. CA3 85 0212-F. THE COMPLAINT ALLEGED FRAUD, VIOLATION OF SECTION 4B(A) AND (C) OF THE COMMODITY EXCHANGE ACT, BREACH OF FIDUCIARY DUTY BY A CO-FIDUCIARY REGARDING AN ERISA PENSION PLAN, BREACH OF CONTRACT, COMMON LAW FRAUD, VIOLATION OF THE TEXAS DECEPTIVE TRADE PRACTICES AND CONSUMER PROTECTION ACT, AND DAMAGES AS FOLLOWS: DAMAGES IN THE AMOUNT OF \$127,682.27 PLUS INTEREST, DAMAGES IN THE AMOUNT OF PLAINTIFF'S LOSS OF INTEREST AND ALL OTHER EARNINGS ON FUNDS WHOSE USE PLAINTIFF WAS DEPRIVED, TREBLE DAMAGES, REASONABLE ATTORNEY FEES, AND SUCH OTHER AND FURTHER RELIEF AS IS DEEMED JUST AND PROPER. THE COMPLAINT WAS SUBSEQUENTLY SETTLED FOR AN AMOUNT IN EXCESS OF \$5,000. (COPY OF COMPLAINT REC'D) THE ABOVE-REFERENCED CIVIL COMPLAINT FILED BY [CUSTOMER], WAS SETTLED ON SEPTEMBER 5, 1986, IN THE AMOUNT OF \$124,600.80. JENNINGS STATES THAT HE DID NOT CONTRIBUTE ANY FUNDS TO THIS SETTLEMENT.
