FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Broker Statement

THE FIRM DENIED THE COMPLAINT VIA A LETTER TO THE CLIENT ON FEBRUARY 17, 2009. BASED UPON THE FIRM'S REVIEW, IT APPEARED THAT THE INVESTMENTS THAT WERE PURCHASED AND SOLD FOR THE CLIENT'S IRA ACCOUNT DURING THAT TIME PERIOD WERE CONSISTENT WITH HIS GROWTH AND INCOME INVESTMENT OBJECTIVES AND HIS MODERATE RISK TOLERANCE. THE CLIENT'S IRA ACCOUNT OUTPERFORMED THE MAJOR STOCK AVERAGES OVER ONE (1), FIVE (5) AND TEN (10) YEAR TIME PERIODS. FROM INCEPTION THROUGH SEPTEMBER 30, 2008 THE CLIENT'S IRA ACCOUNT ACHIEVED A NET DOLLAR WEIGHTED RETURN OF 11.3%. BASED UPON THE FIRM'S REVIEW, THERE WAS NO EVIDENCE TO SUGGEST THAT THE CLIENT'S IRA ACCOUNT WAS MISMANAGED BY EITHER THE FIRM OR THE FA. IT APPEARED THAT THE PERFORMANCE OF THE CLIENT'S INVESTMENTS WAS THE RESULT OF MARKET FORCES THAT WERE BEYOND THE CONTROL OF EITHER THE FIRM OR ITS ASSOCIATES.
